UTILITY BILL 559-585-2510

Your utility bill from the City includes charges for water, sewer, and refuse, which are due upon presentation and delinquent after 15 days. Effective July 1, 2008, a 10% penalty is charged on all delinquent accounts. The City may also charge interest at the rate of 1.5% per month on delinquent amounts.

ADDITION OF DELINQUENT UTILITY FEES TO TAX ROLL/TAX BILL – NOTIFICATION OF LANDOWNER

California Health & Safety Code § 5473 allows the City of Hanford (City) to add delinquent utility fees, penalties, and interest to the tax roll/tax bill for the property at which City-provided utility services are received. Chapter 13.08 of the Hanford Municipal Code says that, if a customer does not pay all utility fees, penalties, and interest in full within ninety (90) days of the date of a utility bill, the City will notify the property owner if such amounts will be added to the tax roll/tax bill.

If you are a tenant renting a home or a commercial building, the City may, in its sole discretion, notify the owner of the property if your account becomes delinquent.

WATER USE

Even Numbered House	Tuesday & Saturday	*These days are subject to change pending water use restrictions. Contact: 559-585-3507
Odd Numbered House	Wednesday & Sunday	*No watering within 48 hours after measurable rainfall.

You MAY NOT.....

Water any day between 10:00am and 6:00pm during daylight savings time.
Use water outside on Monday, Thursday or Friday (includes washing cars).
Water from midnight to 5:00am unless controlled by an automatic timer or a person is in immediate attendance of device.
Leave open hoses for irrigation unattended; willfully or negligently waste water in any manner.
The first violation will result in a \$50.00 fee added to your utility bill; further violations will result in additional fees per ordinance 17-07.

AUTOMATED TRASH COLLECTION, 559-585-2551 Division of Solid Waste

Containers should be out the ***night before*** your scheduled pick up, as crews start at 5:00am. Lids must be closed. Containers must be removed from the curb on the same day they are emptied.

Green waste (Green Can)	Grass clippings, weeds, leaves, small branches, wood (w/o nails, glue, or paint), plant material, and saw dust.
Recycling (Blue Can)	Paper: boxes/cereal & cracker, newspapers, magazines, computer paper, phone books Food Containers: milk cartons, tin cans, aluminum, glass, plastic

Failure to comply with these regulations will result in a violation of the Green Waste/Recycling policy and additional handling fees. City of Hanford Resolution #99-55 establishes fees for violating the City's Segregated Green waste/Recycling Program. The first violation will result in a \$35.00 fee added to your utility bill; further violations will result in additional fees. Additionally, recycling containers are located at the elementary schools. You may choose to dispose of your recyclables (not green waste) at the school sites and the schools will earn money from the recyclables.
